The FRIENDS<sup>TM</sup> Experience: The One in Boston 30 Years of FRIENDS Ticket Giveaway Sweepstakes Official Rules

OFFICIAL RULES (the "Official Rules"): NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING A PRIZE (AS DEFINED HEREIN). YOU HAVE NOT YET WON. VOID WHERE PROHIBITED. OPEN TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA, AT LEAST 18 YEARS OLD OR AGE OF MAJORITY, WHICHEVER IS OLDER IN THEIR STATE OF RESIDENCE, OR OLDER, AT DATE OF ENTRY INTO THE SWEEPSTAKES (AS DEFINED HEREIN). VOID IN PUERTO RICO, ALL OTHER U.S. TERRITORIES AND POSSESSIONS, OUTSIDE OF THE UNITED STATES AND WHERE PROHIBITED BY LAW.

- 1. **General Information**: The FRIENDS<sup>TM</sup> Experience: The One in Boston 30 Years of FRIENDS Ticket Giveaway Sweepstakes (the "Sweepstakes") is sponsored by OGX Media Experiences, LLC (the "Sponsor") and begins on June 30, 2024, at 8:00:00 AM Eastern Standard Time ("EST") and ends on October 31, 2024, at 8:00:00 AM EST (the "Sweepstakes Period"). The Sponsor's computer will be the official time clock for this Sweepstakes. This Sweepstakes is not sponsored, endorsed or administered by, or associated with Facebook, Twitter, Instagram or any other third-party website or application that might host content where information about this Sweepstakes is published (collectively, the "Content Hosts"). Warner Bros. Consumer Products Inc. is not a Sponsor of the Sweepstakes.
- 2. Eligibility: Participation is open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years old or age of majority, whichever is older in their state of residence, or older, at the time of entry and who at the time of entry have a valid and active email address and have subscribed to The Friends Experience newsletter. Warner Bros. Consumer Products Inc. Participants must visit the official website and complete the subscription form with all required information, including but not limited to a valid email address. Entries must not contain any material created by any third party. Entries must not contain any email addresses, domain names or URL links, phone numbers, physical addresses or other forms of contact or personal information. Any entry that does not comply with these Official Rules will be deemed ineligible and may be deleted at the sole discretion of Sponsor.

- 4. Entry Limitations: Limit one (1) Sweepstakes entry per person / household address / email address per day over the course of the Sweepstakes Period. If it is discovered that a participant has attempted to enter under multiple identities or uses any other method or device to enter multiple times per day during the Sweepstakes Period, such participant will be disqualified. Participants are solely responsible for Internet connectivity, software, and/or hardware, which is required in order to enter the Sweepstakes. All entries must be submitted in accordance with these Official Rules, and no other method of entry into this Sweepstakes will be permitted. Entries will not be acknowledged or returned. Entries must be made by an individual only. Group entries are prohibited. - 5. **Drawing Winner Selection & Notification**: On each of the following dates, one (1) potential winner will be randomly selected from among all eligible entries received by 11:59 PM (local time) on that date: June 30, July 7, 14, 21, 28, August 4, 11, 18, 25, and September 1, 2024. ODDS OF WINNING THE SWEEPSTAKES PRIZE DEPENDS UPON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED BY THE ENTRY DEADLINE ON **EACH RESPECTIVE DATE.** Sponsor or Sponsor's representative will attempt to notify the potential winner using the contact information supplied by the entrant during the Sweepstakes entry process. The potential Prize winner will be notified by email within twenty-four (24) hours of the winner selection date.
